Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand-assembled raised, 14ct yellow and white gold & gemstone set, cluster ring. Plain, narrow, low half round, tapered band, measures 2.56mm width (at base) x 0.87mm depth, with open back.

Feature, "cluster style" ring design. Comprising, a raised four claw setting to centre in white gold, houses one oval-cut, faceted, natural sapphire, claw set. The extended shoulders, of the band, tapers up to the top, splits into three rows. Contains total fourteen round brilliant cut diamonds, claw set.



Polished finish, stamped "585 14K" - acid tested as 14 carat gold. Finger size = O1/2.

The ring contains;

One claw set oval-cut, faceted, shaped natural sapphire, colour is "dark blue"

Dimensions = 7.25mm (L) x 5.81mm (W) x 4.03mm (D-estimated)

Total Weight = 1.38ct (estimated - see NOTE below).

Fourteen claw set round brilliant cut diamonds, clarity is "P2 & P3"(mixed), colour is "H to I"(mixed), medium cut quality.

Dimensions = 1.50mm (average diameter) x 0.92mm (D-estimated)

Total Weight = 0.18ct (estimated - see NOTE below).

Total Item Weight = 4.42 grams, Total Gemstone Weight = 1.56ct, Total Metal Weight = 4.11 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
