Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand finished raised, 18ct rose gold & synthetic moissanite set, multistone ring. Plain, narrow, low half round, tapered band, measures 1.35mm width (at base) x 1.12mm depth, with curved underrail, open back settings, underneath.

Feature; "single row" style, runs across the top of the band, shared claw set. The extended shoulders, of the band, tapers up to pointed end terminations, to both sides.

Polished finish, stamped "G18K" - acid tested as 18 carat gold.

Finger size = H.

The ring contains;

Nine claw set round synthetic moissanites, colour is "colourless".

Dimensions = 2.49mm (average diameter) x 1.52mm (D-estimated)

Total Weight = 0.50ct (estimated - see NOTE below).

Total Item Weight = 1.50 grams, Total Gemstone Weight = 0.50ct, Total Metal Weight = 1.40 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the synthetic moissanite cannot be ascertained. Therefore, weight of the synthetic moissanite are very much estimated. For accurate testing, weights, colour, and clarity gradings, synthetic moissanite would require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
