## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 14ct white gold, multistone, gem set ring, of cast construction.

Plain, narrow, tapered band of 1.72mm in width (at base) x 1.05mm depth, with hollow top and shoulders, and open back settings.

Feature 'bon-bon' style ring design, across the top of the plain and polished band. Each setting having one baguette cut natural sapphire, rub-over set. Alternating with eight round brilliant cut diamonds, bead set to each sapphire end. Millegrain edging to all edges.

Polished finish - stamped '14K K.T. 0.03 0.16' - acid tested as 14 carat gold. Finger size is N.

The ring contains:

Three rub over set baguette cut natural sapphires, colour 'dark blue'.

Dimensions (average) = 2.40mm(L) x 1.50mm(W) x 0.85mm(D-estimated)

Total Weight = 0.16ct (estimated - see NOTE below)

Eight bead set round brilliant cut diamonds, clarity 'Si', colour 'G to H' (mixed).

Dimensions (average) = 1.00mm(Dia) x 0.61mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.03ct (estimated - see NOTE below)

Total Item Weight = 1.62 grams - Total Gemstone Weight = 0.19ct - Total Metal Weight = 1.58 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
