Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold and rhodium plated, multistone, gem set ring, of cast construction.

Plain, narrow, tapered band of 1.81mm in width (at base) x 1.26mm depth, with hollow top and shoulders, and open back settings.

Feature single row spanning across the top of the plain and polished band, housing twelve round brilliant cut diamonds, tapering in size, channel set. Rhodium plating to the setting area.



Polished finish.

Stamped '9K' - acid tested as 9 carat gold.

Finger size is N.

The ring contains:

Twelve channel set round brilliant cut diamonds, clarity 'Si & P1' (mixed), colour 'H to I' (mixed).

Dimensions = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.75mm(Dia) x 1.07mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.21ct (estimated - see NOTE below)

Total Item Weight = 2.07 grams Total Gemstone Weight = 0.21ct

Total Metal Weight = 2.03 grams (estimated)
