Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct white gold, cluster style, gem set, dress ring, of cast construction.

Plain, narrow, tapered band of 2.16mm in width (at base) x 1.24mm depth, with hollow top and shoulders and open back settings.

Feature central 'cluster' style setting, housing seven round brilliant cut diamonds, largest to the centre, claw set. Secured between the 'cross-over' style shoulders of the plain and polished band. Each shoulder having four round brilliant cut diamonds, tapering in size, bead set.



Polished finish - stamped '375' - acid tested as 9 carat gold. Finger size is M.

The ring contains:

Seven claw set round brilliant cut diamonds, clarity 'Si & P1' (mixed), colour 'H to I' (mixed).

Dimensions = 1.95mm(Dia) x 1.19mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.25mm(Dia) x 1.37mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.20ct (estimated - see NOTE below)

Eight bead set round brilliant cut diamonds, clarity 'Si & P1' (mixed), colour 'H to I' (mixed).

Dimensions = 1.00mm(Dia) x 0.61mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.05ct (estimated - see NOTE below)

Total Item Weight = 2.93 grams - Total Gemstone Weight = 0.25ct - Total Metal Weight = 2.88 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
