Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 18ct rose gold, cluster style, gem set, dress ring.

Plain, narrow band of 1.99mm in width (at base) x 1.55mm depth, with open back 'centre' setting.

Feature central four claw setting, housing one oval-shape brilliant cut diamond, claw set. Surrounded by sixteen round brilliant cut diamonds (smallest), claw set. Each shoulder of the plain and polished band having seven round brilliant cut diamonds, largest, claw set.



Polished finish - stamped '750 & illegible stamp' - acid tested as 18 carat gold. Finger size is L 1/2.

The ring contains:

One claw set oval shape diamond, clarity 'Vs2', colour 'E'.

Dimensions = 6.18mm(L) x 4.47mm(W) x 2.85mm(D-estimated) x 4%(Girdle Thickness)

Total Weight = 0.50ct (known weight - see NOTE below)

Thirty claw set round brilliant cut diamonds, clarity 'Vs', colour 'F/G'.

Dimensions = 1.20mm(Dia) x 0.73mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.35ct (estimated - see NOTE below)

Total Item Weight = 3.09 grams - Total Gemstone Weight = 0.85ct - Total Metal Weight = 2.92 grams (estimated)

NOTE: The centre diamond has been certified by Messrs. Gemological Institute of America (GIA) laboratory Certificate number: 5201895104 Dated: Feb 05, 2020. The centre diamond has also been laser inscribed upon the girdle with GIA (logo) and 52010895104. Due to setting constraints, the exact dimensions of the surrounding and shoulder diamonds cannot be ascertained. Therefore, weights of the surrounding and shoulder diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the surrounding and shoulder diamonds require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
