Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold and 18ct yellow gold, gem set, multistone pendant, of hand-assembled construction.

Feature round top plate, within a decorative pierced four claw setting, housing nine round brilliant cut diamonds, largest to the centre, claw set. The pendant is finished with an oval yellow gold articulated bail. The bail is embellished with one row of five round brilliant cut diamonds, bead set.

Pendant dimensions = 15.30mm (ave. length) x 7.76mm (ave. width) x 5.35mm (ave. depth).

Polished finish.

Stamped '750 D 0.20ct d 0.28ct' - acid tested as 18 carat gold.

The pendant contains:

One claw set round brilliant cut diamond, clarity is "Si1", colour is "H".

Dimensions = 3.53mm(Dia) x 2.19mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.20ct (estimated - see NOTE below)

Fourteen claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).

Dimensions = 1.35mm(Dia) x 0.82mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.79mm(Dia) x 1.09mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.28ct (estimated - see NOTE below)

Total Item Weight = 1.26 grams Total Gemstone Weight = 0.48ct Total Metal Weight = 1.16 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
