Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand-assembled raised, 18ct yellow and white gold & diamond set, cluster dress ring. Plain, narrow, low half round, tapered band, measures 2.05mm width (at base) x 1.02mm depth, with curved underrail.

Feature, "cluster style" ring design, with shoulder stones. Comprising, white gold, basket setting to centre, houses one round brilliant cut diamond, bead set. Drops to a surround, housing ten single cut diamonds, bead set. The extended shoulders, of the yellow gold band tapers up. Each shoulder having a navette-shaped white gold setting, on top, contains two single cut diamonds, each bead set, both sides.

Polished finish, stamped "18ct" - acid tested as 18 carat gold. Finger size = S.

The ring contains;

One bead set round brilliant cut diamond, clarity is "Si", colour is "G", medium cut quality.
Dimensions = 4.04mm (diameter) x 2.46mm (D-estimated)
Total Weight = 0.25ct (estimated - see NOTE below).

Fourteen bead set single cut diamonds, clarity is "Vs & Si"(mixed), colour is "G to H"(mixed), medium cut quality.
Dimensions = 1.35mm (average diameter) (smallest)
Dimensions = 1.48mm (average diameter) (largest)
Total Weight = 0.20ct (estimated - see NOTE below).

Total Item Weight = 3.83 grams, Total Gemstone Weight = 0.45ct, Total Metal Weight = 3.74 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
