## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, lady's raised 9ct yellow gold & gemset, cluster ring, of cast construction. Plain, narrow, low half round, tapered band, measures 2.01mm width (at base) x 1.28mm depth, with curved underrail, open back settings, rhodium plated underneath, to highlight.

Feature, "cluster style" ring design, with shoulder stones. Comprising, a raised four claw setting to centre top, contains one oval-shaped, faceted natural sapphire, claw set. Drops to a surround, contains fourteen round brilliant cut diamonds, claw set. The extended shoulders, of the band, tapers up wide, each shoulder splits to a double channel set row, contains eight round brilliant cut diamonds, tapering sizes, channel set both sides.



Polished finish, stamped "9K 1K" - acid tested as 9 carat gold. Finger size = T.

The ring contains;

One claw set oval shaped natural sapphire, colour is "very dark, bluish green".

Dimensions = 7.07mm (L) x 5.07mm (W) x 3.14mm (D-estimated)

Total Weight = 0.93ct (estimated - see NOTE below).

Thirty claw set round brilliant cut diamonds, clarity is "Si, P1 & P2"(mixed), colour is "H to J"(mixed), medium cut quality.

Dimensions = 1.27mm (average diameter) x 0.77mm (D-estimated) (smallest)

Dimensions = 1.94mm (average diameter) x 1.18mm (D-estimated) (largest)

Total Weight = 0.75ct (estimated - see NOTE below).

Total Item Weight = 4.29 grams, Total Gemstone Weight = 1.68ct, Total Metal Weight = 3.95 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
