Valuation for Traditional Retail Insurance Replacement

One, lady's hand-assembled raised, 20ct yellow gold & gemstone set, flexible link bracelet.

Feature, "line style" bracelet. Comprising, twelve v-claw navet shaped settings, alternate with a flexible ribbed barrel link inbetween. Each navette shaped setting, contains a navette shaped, cabochon cut jade style gemstone, (mixed) colours, claw set. The bracelet having a box tongue clasp closure attached to end.

Polished finish, stamped "22K" - acid tested & x-rayed approximately 20 carat gold.

Bracelet dimensions = 18.00cm (L) x 5.29mm (W) x 2.65mm - 1.68mm (depth).

The bracelet contains:

Twelve claw set marquise jadeite type cabochons, colour is mixed (white, black, brown, green, orange).

Average dimensions = 12.00mm (L) x 4.50mm (W) x 1.57mm (D-estimated)

Total Weight = 8.40ct (estimated - see NOTE below).

Total Item Weight = 7.19 grams, Total Gemstone Weight = 8.40ct, Total Metal Weight = 5.51 grams (estimated)

NOTE: Limited gemmological testing, inset.Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
