## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 9ct yellow gold, gem set, multistone ring, of cast construction.

Plain, narrow, low half round, tapered band of 2.39mm width (at base) x 0.93mm depth, with a hollow top and shoulders, open back settings, and a curved underrail.

Feature five decorative settings, each housing one round natural ruby, spanning across the top of the band, and claw set. Alternating with two round brilliant cut diamonds, bead set. There are a total of eight round brilliant cut diamonds. The settings are secured between the tapering shoulders of the plain and polished band.

Polished finish.

Stamped 'MHJ9CT E' - acid tested as 9 carat gold.

Ring size: R.

The ring contains:

Five claw set round natural rubies, colour is "red".

Dimensions (average) = 3.03mm(Dia) x 1.85mm(D-estimated)

Total Weight = 0.61ct (estimated - see NOTE below)

Eight bead set round brilliant cut diamonds, clarity is "Si", colour is "H to I" (mixed).

Dimensions (average) = 1.00mm(Dia) x 0.61mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.04ct (estimated - see NOTE below)

Total Item Weight = 3.36 grams Total Gemstone Weight = 0.65ct Total Metal Weight = 3.23 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
