Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, multistone, 'cluster' style ring, of cast construction.

Plain, narrow, low half round, tapered band of 3.13mm width (at base) x 1.24mm depth.

Feature central round top plate within a six claw setting, housing eleven round brilliant cut diamonds, largest to the centre, claw set. The decorative setting is secured in between the extended and pointed shoulders, of the plain and polished band.

Polished finish.

Stamped '18K 750 unknown makers mark' - acid tested as 18 carat gold.

Ring size: L.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Si2", colour is "G".

Dimensions = 4.75mm(Dia) x 2.90mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.40ct (estimated - see NOTE below)

Ten claw set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "G to H" (mixed).

Dimensions (average) = 2.11mm(Dia) x 1.29mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.35ct (estimated - see NOTE below)

Total Item Weight = 5.27 grams Total Gemstone Weight = 0.75ct Total Metal Weight = 5.12 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
