Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's raised, 18ct yellow gold & diamond set, multistone ring, of cast construction. Plain, narrow, low half round, tapered band, measures 2.27mm width (at base) x 1.17mm depth, with open back, settings underneath.

Feature, "step down dress style" ring design. Comprising, a raised four claw setting to centre, houses one Princess cut diamond, claw set. Drops down each side two channel settings, each contain three baguette cut & tapered baguette cut diamonds (mixed), all channel set. The extended shoulders, of the band taper up wide to the top, from both sides.

Polished finish, stamped "JY 18K [O]" - acid tested as 18 carat gold. Finger size = S1/2.

The ring contains;

One claw set Princess cut diamond, clarity is "Vs", colour is "I", medium cut quality.

Dimensions = 4.33mm (L) x 4.27mm (W) x 3.08mm (D-estimated) x 3%(Girdle Thickness)
Total Weight = 0.50ct (estimated - see NOTE below).

Twelve channel set baguette cut & tapered baguette cut diamonds (mixed), clarity is "Vs & Si"(mixed), colour is "I to J"(mixed), medium cut quality.

Average dimensions = 2.63mm (L) x 1.39mm (W) x 1.01mm (D-estimated)
Total Weight = 0.40ct (estimated - see NOTE below).

Total Item Weight = 6.80 grams, Total Gemstone Weight = 0.90ct, Total Metal Weight = 6.62 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
