### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, 18ct yellow gold and 18ct white gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 2.97mm width (at base) x 1.52mm depth, with open back settings, and a curved underrail.

Feature central white gold bezel setting, housing one Princess cut diamond, bezel set. The setting is secured in between the extended and square shoulders, of the plain and polished yellow gold band. Each of the shoulders houses one row of three single cut and round brilliant cut (1) diamonds, channel set.

Polished finish.

Stamped '750' - acid tested as 18 carat gold.

Ring size: P 1/2.

The ring contains:

One bezel set Princess cut diamond, clarity is "Vs", colour is "H".

Dimensions = 3.70mm(L) x 3.70mm(W) x 2.64mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.31ct (estimated - see NOTE below)

Six channel set single cut and round brilliant cut (1) diamonds, clarity is "Vs & Si & P1" (mixed), colour is "H to I" (mixed).

Dimensions = 1.22mm (diameter) (smallest)

Dimensions = 1.41mm (diameter) (largest)

Total Weight = 0.05ct (estimated - see NOTE below)

Total Item Weight = 6.84 grams Total Gemstone Weight = 0.36ct Total Metal Weight = 6.77 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
