Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 1.71mm width (at base) x 1.34mm depth, with a curved underrail.

Feature central bezel setting, housing one Princess cut diamond, bezel set. Surrounding is one row of twenty round brilliant cut diamonds, claw set. The central setting, gallery, and shoulders are embellished with a total of twenty-eight round brilliant cut and single cut (1) diamonds, claw and bezel set. The extended and square shoulders, lengthen out from the plain and polished band. Millegrain detail to the edges of the settings.

Polished finish.

Stamped '750 RAND' - acid tested as 18 carat gold.

Ring size: J 1/2.

The ring contains:

One bezel set Princess cut diamond, clarity is "Vs", colour is "I".

Dimensions = 4.18mm(L) x 4.11mm(W) x 3.05mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.44ct (estimated - see NOTE below)

Fifty claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to I" (mixed).

Dimensions = 1.00mm(Dia) x 0.61mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.85mm(Dia) x 1.13mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.25ct (estimated - see NOTE below)

Total Item Weight = 3.72 grams Total Gemstone Weight = 0.69ct Total Metal Weight = 3.58 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
