## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 18ct yellow gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round double band of 3.15mm width (at base) x 0.85mm depth, with open back settings.

Feature assymetrical design with a four claw setting, to one side, housing one round brilliant cut diamond, claw set. There is three 'leaf' style settings, housing a total of twelve round brilliant cut diamonds, graduating in size, largest to the centre, and channel set. The settings are secured between the shoulders of the plain and polished band. The two bands are secured together at the back of the band.



Polished finish.

Stamped '750' - acid tested as 18 carat gold.

Ring size: N.

The ring contains:

One bezel set round brilliant cut diamond, clarity is "P2", colour is "H".

Dimensions = 3.37mm(Dia) x 2.02mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.16ct (estimated - see NOTE below)

Twelve channel set round brilliant cut diamonds, clarity is "Si", colour is "H".

Dimensions = 1.38mm(Dia) x 0.84mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.70mm(Dia) x 1.04mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.20ct (estimated - see NOTE below)

Total Item Weight = 5.18 grams Total Gemstone Weight = 0.36ct Total Metal Weight = 5.11 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
