One, 18ct yellow gold, gem set, multistone ring, of cast consturction.

Plain, narrow, low half round, tapered band of 2.14mm width (at base) x 1.09mm depth, with open back settings.

Feature central channel setting, in a 'wrap around' style, housing one Princess cut diamond, end set. Each of the extended and square shoulders, houses one row of four Princess cut diamonds, graduating in size, and channel set. The shoulders lengthen out from the plain and polished band



Polished finish.

Stamped '18K michael hill H47765 1.00' - acid tested as 18 carat gold.

Ring size: L.

The ring contains:

One end set Princess cut diamond, clarity is "Si2", colour is "H".
