One, 18ct yellow gold, gem set, stud earring, of hand-assembled construction.

Feature railed four claw setting, housing one round brilliant cut diamond, claw set. The earring is finished with a post and butterfly attachment.

Earring dimensions = 3.96mm (ave. length) x 3.96mm (ave. width) x 4.03mm (ave. depth).

Polished finish.

Stamped '750' - acid tested as 18 carat gold.

The earring contains:

One claw set round brilliant cut diamond, clarity is "P2", colour is "G".
Dimensions = 3.95mm(Dia) x 2.50mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.24ct (estimated - see NOTE below)

Total Item Weight = 0.80 grams
Total Gemstone Weight = 0.24ct
Total Metal Weight = 0.75 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar earring employing similar materials and techniques being for a retail insurance purpose only.
