Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, half round band of 3.68mm width (at base) x 2.04mm depth, with open back settings, and a curved underrail.

Feature central six claw setting, housing one round brilliant cut diamond, claw set. The setting is secured to the underrail, and in between the extended and pointed shoulders, of the plain and polished band. Each of the shoulders, houses one row of seven round brilliant cut diamonds, graduating in size, claw set.



Polished finish.

Stamped '750' - acid tested as 18 carat gold.

Ring size: M.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Si1", colour is "I".

Dimensions = 5.98mm(L) x 5.95mm(W) x 3.90mm(D-estimated) x 5%(Girdle Thickness)

Total Weight = 0.88ct (estimated - see NOTE below)

Fourteen claw set round brilliant cut diamonds, clarity is "Si", colour is "H to I" (mixed).

Dimensions = 1.10mm(Dia) x 0.67mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.35mm(Dia) x 0.82mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.12ct (estimated - see NOTE below)
