Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, multistone ring, of cast construction.

Plain, narrow, low half round, tapered band of 2.51mm width (at base) x 1.26mm depth, with open back settings.

Feature one row of nine round brilliant cut diamonds, alternating with eight baguette cut diamonds, spanning across the top of the band. The settings are secured between the shoulders of the plain and polished band. There is one decorative groove to the top and the bottom of the band, framing the central settings.

Polished finish.

Stamped '750 MHJ' - acid tested as 18 carat gold.

Ring size: O.

The ring contains:

Nine channel set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "H".

Dimensions (average) = 1.77mm(Dia) x 1.08mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.21ct (estimated - see NOTE below)

Eight channel set baguette cut diamonds, clarity is "Vs & Si" (mixed), colour is "H".

Dimensions (average) = 1.80mm(L) x 0.80mm(W) x 0.58mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.08ct (estimated - see NOTE below)

Total Item Weight = 4.31 grams Total Gemstone Weight = 0.29ct Total Metal Weight = 4.25 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
