## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 18ct yellow gold and 18ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 1.68mm width (at base) x 0.81mm depth, with open back settings.

Feature 'flower' style cluster, with a central white gold illusion setting, housing one round brilliant cut diamond, illusion set. Surrounding is twelve round brilliant cut diamonds, claw set. The top plate is supported with an open wire base, and is secured to the top of the plain and polished yellow gold band.

Polished finish.

Stamped 'LAT' - acid tested as 18 carat gold.

Ring size: N 1/2.

The ring contains:

One illusion set round brilliant cut diamond, clarity is "Si1", colour is "I".

Dimensions = 4.82mm(Dia) x 2.94mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.45ct (estimated - see NOTE below)

Twelve claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "H to I" (mixed).

Dimensions = 1.95mm(Dia) x 1.19mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.34ct (estimated - see NOTE below)

Total Item Weight = 4.81 grams Total Gemstone Weight = 0.79ct Total Metal Weight = 4.65 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
