Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, 'solitaire' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.06mm width (at base) x 1.16mm depth, with a curved underrail.

Feature central railed four claw setting, housing one Princess cut diamond, claw set. The setting is secured between the extended and pointed shoulders, of the plain and polished band.

Polished finish.

Stamped 'H37969 750 michael hill' - acid tested as 18 carat gold.

Ring size: N 1/2.

The ring contains:

One claw set Princess cut diamond, clarity is "Si2", colour is "H".

Dimensions = 4.16mm(L) x 3.95mm(W) x 3.27mm(D-estimated) x 7.9%(Girdle Thickness)

Total Weight = 0.50ct (known weight - see NOTE below)

Total Item Weight = 3.24 grams

Total Gemstone Weight = 0.50ct

Total Metal Weight = 3.14 grams (estimated)

NOTE: The diamond has been certified by Messrs. Australian Diamond Grading Laboratory Certificate number: H37969 Dated: 28/03/2013. The diamond has also been laser inscribed upon the girdle with ADGL (logo) and H37969 and michael hill. No diamond certificate or paperwork was presented at the time of this valuation. Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
