Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold and 9ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.08mm width (at base) x 1.22mm depth, with a hollow top and shoulders, open back settings, and a curved underrail.

Feature three round white gold clusters, graduating in size, largest to the centre, spanning across the top of the band. Each of the clusters, houses seven round brilliant cut diamonds, claw set. The settings are secured between the extended and pointed shoulders, of the plain and polished yellow gold band.

Polished finish.

Stamped '375 JP88' - acid tested as 9 carat gold.

Ring size: O.

The ring contains:

Twenty One claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "H to I" (mixed).

Dimensions = 1.70mm(Dia) x 1.04mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.70mm(Dia) x 1.65mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.59ct (estimated - see NOTE below)

Total Item Weight = 2.27 grams

Total Gemstone Weight = 0.59ct

Total Metal Weight = 2.15 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
