Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's, hand finished, raised 14ct white gold & gemstone set (mixed), multistone ring. Plain, narrow, flat, tapered with curved underrail.

Feature, "solitaire style" with shoulder stones. Comprising, a raised four claw setting to centre, houses one square shaped, faceted cubic zirconia, claw set. The extended shoulders, of the band, tapers up to the top. Each shoulder contains eight round brilliant cut diamonds, claw set.

Polished finish, stamped "14K" - acid tested as 14 carat gold. Finger size = K.

The ring contains;

One claw set square-shaped, faceted, cubic zirconia, colour is "colourless".
Dimensions = 6.02mm (L) x 6.02mm (W) x 3.67mm (D-estimated)
Total Weight = 1.76ct (estimated - see NOTE below).

Sixteen claw set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "G to I"(mixed), medium cut quality.
Dimensions = 1.80mm (average diameter) x 1.10mm (D-estimated) (smallest)
Dimensions = 2.00mm (average diameter) x 1.22mm (D-estimated) (largest)
Total Weight = 0.40ct (estimated - see NOTE below).

Total Item Weight = 4.30 grams, Total Gemstone Weight = 2.16ct, Total Metal Weight = 3.87 grams,
(estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
