## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, hand-assembled, 9ct yellow gold and rhodium plated, multistone, gem set ring.

Plain, narrow, tapered band of 1.54mm in width (at base) x 0.77mm depth, with open back settings, and hollow shoulders.

Feature central four claw setting, housing one round brilliant cut diamond, claw set. Secured between the 'cross-over' style shoulders of the yellow gold plain and polished band. Rhodium plating to the setting areas.

Polished finish - stamped '375 GM16' - acid tested as 9 carat gold. Finger size is R.

The ring contains:

One claw set round brilliant cut diamond, clarity 'P2', colour 'brown tint'.

Dimensions = 3.22mm(Dia) x 1.96mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.13ct (estimated - see NOTE below)

Ten channel set round brilliant cut diamonds, clarity 'P1 & P2' (mixed), colour 'H'.

Dimensions = 1.15mm(Dia) x 0.70mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.51mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.12ct (estimated - see NOTE below)

Total Item Weight = 2.00 grams - Total Gemstone Weight = 0.25ct - Total Metal Weight = 1.95 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
