Valuation for Traditional Retail Insurance Replacement



Item 1

One, 9ct yellow gold and rhodium plated, diamond set, multistone, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 1.65mm width (at base) x 1.08mm depth, with hollow top and shoulders, and open back settings.

Feature 'flower' style central cluster, housing seven round brilliant cut diamonds, smallest to the centre, bead set. The central top plate is secured between the extended and pointed shoulders in a 'wrap around' style. Each of the shoulders houses one row of six single cut diamonds, varying in size, and bead set. Rhodium plating to the setting areas. The shoulders lengthen out from the plain and polished band.

Polished finish. Stamped '9K' - acid tested as 9 carat gold. Ring size: K.

The ring contains:

Seven bead set round brilliant cut diamonds, clarity is "P2 & P3" (mixed), colour is "H to I" (mixed).

Dimensions = 1.85mm(Dia) x 1.13mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.07mm(Dia) x 1.26mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.21ct (estimated - see NOTE below)

Twelve bead set single cut diamonds, clarity is "Si & P1" (mixed), colour is "H to I" (mixed).

Dimensions = 0.95mm (diameter) (smallest)

Dimensions = 1.15mm(diameter) (largest)

Total Weight = 0.06ct (estimated - see NOTE below)

Total Item Weight = 2.43 grams Total Gemstone Weight = 0.27ct Total Metal Weight = 2.38 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
