Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, multistone, gem set ring, of cast construction.

Plain, narrow, tapered band of 1.76mm in width (at base) x 1.43mm depth, with open back (cut-out) setting sections.

Feature 'cross-over' ring design, housing six Princess cut diamonds to one side, and five Princess cut diamonds to the opposite, tapering in size, all channel set.

Polished finish.

Stamped '750 MHJ .25' - acid tested as 18 carat gold.

Finger size is J.

The ring contains:

Twelve channel set Princess cut diamonds, clarity 'Si & P1' (mixed), colour 'H'.

Dimensions = 1.50mm(L) x 1.50mm(W) x 0.85mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.70mm(L) x 1.70mm(W) x 1.00mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.25ct (estimated - see NOTE below)

Total Item Weight = 2.60 grams

Total Gemstone Weight = 0.25ct

Total Metal Weight = 2.55 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
