Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, gem set, multistone, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 1.62mm width (at base) x 0.74mm depth x 1.90mm depth, with open back settings, and supported with a curved underail.

Feature one central white gold four claw setting, housing one pear shape natural sapphire, claw set. Surrounding is one row of eleven round brilliant cut diamonds, claw set. The setting is secured between extended and pointed shoulders in a 'cross-over' style.

Polished finish, stamped '750' - acid tested as 18 carat gold. Ring size: K 1/2.

The ring contains:

One claw set pear shaped natural sapphire, colour is "dark blue".

Dimensions = 6.09mm(L) x 4.22mm(W) x 3.20mm(D-estimated)

Total Weight = 0.60ct (estimated - see NOTE below)

Eleven claw set round brilliant cut diamonds, clarity is "Si", colour is "H to J" (mixed).

Dimensions = 1.70mm(Dia) x 1.04mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.90mm(Dia) x 1.16mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.28ct (estimated - see NOTE below)

Total Item Weight = 3.00 grams Total Gemstone Weight = 0.88ct Total Metal Weight = 2.82 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
