Valuation for Traditional Retail Insurance Replacement

One, 9ct yellow gold and rhodium plated, diamond set, multistone ring, of cast construction.

Plain, narrow, low half round, tapered band of 1.49mm width (at base) x 0.99mm depth, with hollow top and shoulders, open back settings, and a curved cut out underrail.

Feature 'crossover' style ring. There are two rows that cross over in the centre of the band. There are a total of thirty-four baguette cut and tapered baguette cut diamonds, graduating in size, largest to the centre, and channel set. The settings are secured between the split shoulders of the plain and polished band. Rhodium plating to the setting areas.

Polished finish.

Stamped '375 D' - acid tested as 9 carat gold.

Ring size: O.

The ring contains:

Thirty Four channel set baguette cut and tapered cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "H to J" (mixed).

Dimensions = 1.40mm(L) x 0.65mm(W) x 0.47mm(D-estimated) x 2% (Girdle Thickness) (smallest)

Dimensions = 1.95mm(L) x 1.17mm(W) x 0.85mm(D-estimated) x 2% (Girdle Thickness) (largest)

Total Weight = 0.25ct (estimated - see NOTE below)

Total Item Weight = 2.20 grams Total Gemstone Weight = 0.25ct Total Metal Weight = 2.15 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
