## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 14ct white gold, diamond set, multistone pendant, of cast construction.

Feature open heart shaped pendant, with twenty-one shared claw settings around the edge, each housing one round brilliant cut diamond, bead set. The diamonds graduate with the largest to the top, and smallest to the bottom. The pendant is finished with a fixed tapered bail.

Pendant dimensions = 20.00mm (ave. length) x 15.00mm (ave. width) x 5.81mm (ave. depth).

Polished finish.

Stamped 'ENV 14K' - acid tested as 14 carat gold.

The pendant contains:

Eight bead set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "G to H" (mixed).

Dimensions (average) = 2.14mm(Dia) x 1.31mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.25ct (estimated - see NOTE below)

Thirteen bead set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "G to H" (mixed).

Dimensions = 1.40mm(Dia) x 0.85mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.00mm(Dia) x 1.22mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.25ct (estimated - see NOTE below)

Total Item Weight = 2.45 grams Total Gemstone Weight = 0.50ct Total Metal Weight = 2.34 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pendant employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
