Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, raised 10ct yellow gold & diamond set, multistone ring, of cast construction. Plain, narrow, low half round, tapered band, measures 2.03mm width (at base) x 1.06mm depth, tapers up 8.05mm width (at top), with cut-out underrail.

Feature, "triple row" style, runs across the band. Comprising, a central row of channel waves, housing thirty three round brilliant cut diamond, channel set. The outer rows each side, contain twenty two single cut diamonds, bead set. The extended shoulders, taper wide to the top, from both sides.



Polished finish, stamped "10K JX" - acid tested approximately 10 carat gold.

Finger size = R1/2.

the ring contains;

Thirty Three channel set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "I-K", medium cut quality.
Dimensions = 1.45mm (average diameter) x 0.88mm (D-estimated)
Total Weight = 0.36ct (estimated - see NOTE below).

Forty Four bead set single cut diamonds, clarity is "Si & P1"(mixed), colour is "I to K"(mixed), medium cut quality.
Dimensions = 0.85mm (average diameter)
Total Weight = 0.18ct (estimated - see NOTE below).

Total Item Weight = 3.65 grams, Total Gemstone Weight = 0.54ct, Total Metal Weight = 3.54 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
