## Valuation for Traditional Retail Insurance Replacement

### Item 1

One lady's, hand finished raised, 18ct yellow gold & rhodium plated, diamond set, solitaire ring.

Plain, narrow, low half round, tapered band, measures 1.17mm width (at base) x 0.98mm depth, with curved underrail, split, hollowed out shoulder, underneath.

Feature "two tone solitaire" style ring design. Comprising, the extended shoulders, of the band, taper up to the top, forming the rub-over setting to top. Houses one round brilliant cut diamond, rub-over set. One side of the band is rhodium plated to give the illusion of a two tone ring.

Polished finish, stamped "18K LI N" - acid tested as 18 carat gold.

Finger size N1/2.

The ring contains;

One rub-over set round brilliant cut diamond, clarity is "Vs", colour is "H", medium cut quality.  
Dimensions = 2.79mm (average diameter) x 1.70mm (D-estimated)  
Total Weight = 0.08ct (estimated - see NOTE below).

Total Item Weight = 2.39 grams, Total Gemstone Weight = 0.08ct, Total Metal Weight = 2.37 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
