Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 18ct yellow gold and rhodium plated, multistone, gem set ring. Plain, narrow, tapered band of 5.17mm at top to 2.37mm in width (at base) x 1.34mm depth, with hollow top and shoulders, open back settings, and a curved, plaited underrail.

Feature central row, channel set with sixteen baguette cut diamonds, slightly tapering in size. The outer rows having thirteen round brilliant cut diamonds, slightly tapering in size also, claw set. Rhodium plating to the setting areas.

Polished finish - stamped '4 7(partial)' - acid tested as 18 carat gold. Finger size is O.



The ring contains:

Sixteen channel set baguette cut diamonds, clarity 'Vs', colour 'G to H' (mixed).

Dimensions = 1.85mm(L) x 1.05mm(W) x 0.60mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = $2.20 \text{mm}(L) \times 1.10 \text{mm}(W) \times 0.60 \text{mm}(D\text{-estimated}) \times 2\%(\overline{G}irdle Thickness)$ (largest)

Total Weight = 0.22ct (estimated - see NOTE below)

Twenty Six claw set round brilliant cut diamonds, clarity 'Vs & Si' (mixed), colour 'G to H' (mixed).

Dimensions = 1.35mm(Dia) x 0.82mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.28ct (estimated - see NOTE below)

Total Item Weight = 4.10 grams - Total Gemstone Weight = 0.50ct - Total Metal Weight = 4.00 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
