Valuation for Traditional Retail Insurance Replacement

Item 1

One, 10ct yellow gold and rhodium plated, diamond set, multistone ring, of cast construction.

Plain, narrow, low half round band of 3.23mm width (at base) x 1.31mm depth, with hollow top, open back settings, and a cut out curved underrail.

Feature central rectangle top plate, housing one horizontal row of three round brilliant cut diamonds, spanning across the top of the band, varying in size, and channel set. The setting groove continues down the shoulders. The central setting is secured between the extended and square shoulders, of the plain and polished band. Rhodium plating to the setting area.

Polished finish.

Stamped 'maple leaf 10K MHJ' - acid tested as 9 carat gold. Ring size: Z+5.

The ring contains:

- Three channel set round brilliant cut diamonds, clarity is "Si", colour is "G to H" (mixed).
Dimensions = 4.35mm(Dia) x 2.65mm(D-estimated) x 2%(Girdle Thickness) (smallest)
- Dimensions = 4.66mm(Dia) x 2.84mm(D-estimated) x 2%(Girdle Thickness) (largest)
- Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 7.77 grams
Total Gemstone Weight = 1.00ct
Total Metal Weight = 7.57 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
