Valuation for Traditional Retail Insurance Replacement

Item 1

One pair of, 9ct yellow gold and rhodium plated, gem set, stud earrings, of hand-assembled construction.

Feature central bezel setting, housing one cushion cut blue topaz, bezel set. There are three round brilliant cut diamonds, to the top and bottom, claw set. The earrings are finished with a post and butterfly findings.

Earring dimensions = 10.85mm (ave. length) x 9.37mm (ave. width) x 5.22mm (ave. depth).

Polished finish.

Stamped '375 0.03' - acid tested as 9 carat gold.

The earrings contain:

Two bezel set square cushion topazes, colour is "blue".

Dimensions (average) = 8.24mm(L) x 7.41mm(W) x 4.90mm(D-estimated)

Total Weight = 5.18ct (estimated - see NOTE below)

Twelve claw set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "G to H" (mixed).

Dimensions (average) = 1.00mm(Dia) x 0.61mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.06ct (estimated - see NOTE below)

Total Item Weight = 4.29 grams Total Gemstone Weight = 5.24ct Total Metal Weight = 3.24 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
