## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, hand-assembled, 9ct yellow gold and rhodium plated, multistone, gem set ring.

Plain, narrow, tapered band of 1.50mm in width (at base) x 1.20mm depth, with a curved and split underrail, hollow top and shoulders, and open back settings.

Feature central raised four 'corner' claw bezel setting, housing nine Princess cut diamonds, invisible set. Surrounded by twenty-four single cut diamonds, claw set. Secured between the extended shoulders, of the plain and polished band. Each shoulder having six single cut diamonds, bead set. Rhodium plating inside the setting areas.

Polished finish - stamped 'illegible' - acid tested as 9 carat gold. Finger size is T.

The ring contains:

Nine invisible set Princess cut diamonds, clarity 'Si & P1' (mixed), colour 'G'.

Dimensions (average) = 2.11mm(L) x 2.10mm(W) x 1.20mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.43ct (estimated - see NOTE below)

Thirty Six bead set single cut diamonds, clarity 'P1 & P2' (mixed), colour 'G to H' (mixed).

Dimensions = 1.22mm (average diameter)

Total Weight = 0.32ct (estimated - see NOTE below)

Total Item Weight = 2.55 grams - Total Gemstone Weight = 0.75ct - Total Metal Weight = 2.40 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
