## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, hand-assembled, 18ct white gold, multistone, gem set ring.

Plain, narrow, tapered band of 1.59mm in width (at base) x 0.86mm depth, with curved underrail, openings at the centre and shoulders (drilled).

Feature central four 'double' claw, 'coronet' style setting, housing one round brilliant cut diamond, claw set. Secured between the extended shoulder plates, each having one round diamond, bead set.

Polished finish - stamped '18CT' - acid tested as 18 carat gold. Finger size is L.

The ring contains:

One claw set early brilliant cut diamond, clarity 'Si', colour 'brown tint'.

Dimensions = 3.60mm(Dia) x 2.27mm(D-estimated) x 2%(Girdle Thickness)  
Total Weight = 0.18ct (estimated - see NOTE below)

One native rose cut style diamond & One round cut and faceted colourless cubic zirconia type material, bead set.

Dimensions (average) = 1.13mm(Dia) x 0.62mm(D-estimated) x 2%(Girdle Thickness)

Total Item Weight = 1.58 grams.

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring using all modern round brilliant cut diamonds of the same estimated weight, colour and clarity employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
