## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, hand-assembled, 14ct rose gold and 14ct white gold, cluster style, gem set, dress ring.

Plain, narrow, tapered band of 1.30mm in width (at base) x 1.08mm depth, with curved underrail, hollow and open back at each shoulder.

Feature white gold six claw 'cluster' style setting, housing seven round brilliant cut diamonds, largest to the centre, sunken set. Secured between the shoulders of the yellow gold plain and polished band. Each shoulder having five round brilliant cut diamonds, tapering in size, channel set.

Polished finish.

Stamped '14KT 0.50' - acid tested as 14 carat gold.

Finger size is O.

The ring contains:

- Seventeen sunken set, claw set & channel set (mixed) round brilliant cut diamonds, clarity 'Si & P1' (mixed), colour 'G to I' (mixed).
- Dimensions = 1.90mm(Dia) x 1.16mm(D-estimated) x 2%(Girdle Thickness) (smallest)
- Dimensions = 2.10mm(Dia) x 1.28mm(D-estimated) x 2%(Girdle Thickness) (largest)
- Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 2.65 grams

Total Gemstone Weight = 0.50ct

Total Metal Weight = 2.55 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
