Valuation for Traditional Retail Insurance Replacement

One, 14ct yellow gold and rhodium plated, multistone, gem set ring, of cast construction.

Plain, narrow, tapered band of 2.96mm in width (at base) x 1.54mm depth, with open back (cutout) settings.

Feature single row spanning across the top of the plain and polished band, housing eleven round brilliant cut diamonds, tapering in size, channel set. Rhodium plating inside the setting



Polished finish.

Stamped '585' - acid tested as 14 carat gold.

Finger size is K.

The ring contains:

Eleven channel set round brilliant cut diamonds, clarity 'Si & P1' (mixed), colour 'H'.

Dimensions = 2.75mm(Dia) x 1.68mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 3.35mm(Dia) x 2.04mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 4.95 grams Total Gemstone Weight = 1.00ct

Total Metal Weight = 4.75 grams (estimated)

For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
