Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold, 'solitaire' design, diamond set ring, of cast construction.

Plain, narrow, tapered band of 2.00mm in width (at base) x 1.25mm depth, with a curved and cut-out underrail.

Feature 'solitaire' style ring design, consisting of a six claw 'coronet' style setting, housing one round brilliant cut diamond, claw set. Secured between the extended shoulders of the plain and polished band. Each shoulder having a small chenier support.

Polished finish.

Stamped '375 GA DIA p.25' - acid tested as 9 carat gold.

Finger size is P.

The ring contains:

One claw set round brilliant cut diamond, clarity 'P1', colour 'H'.

Dimensions = 3.92mm(L) x 3.90mm(W) x 2.50mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.25ct (estimated - see NOTE below)

Total Item Weight = 2.28 grams

Total Gemstone Weight = 0.25ct

Total Metal Weight = 2.23 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
