Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, diamond set, multistone ring, of hand-assembled

Plain, narrow, low half round, tapered band of 2.29mm width (at base) x 1.25mm depth, with open back (cut out) settings, and a curved underrail.

Feature central railed white gold railed channel setting, housing one Princess cut diamond, end set. The setting is secured in between the extended and square shoulders, of the plain and polished yellow gold band. Each of the shoulders has one row of two Princess cut diamonds, with a baguette cut diamond in the centre, and channel set.



Polished finish. Stamped '750 AC16' - acid tested as 18 carat gold. Ring size: K.

The ring contains:

One end set Princess cut diamond, clarity is "Si2", colour is "I".

Dimensions = 3.90mm(L) x 3.87mm(W) x 2.85mm(D-estimated) x 7%(Girdle Thickness)

Total Weight = 0.38ct (estimated - see NOTE below)

Two channel set baguette cut diamonds, clarity is "Si", colour is "H".

Dimensions (average) = 2.80mm(L) x 1.90mm(W) x 1.39mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.12ct (estimated - see NOTE below)

Four channel set princess cut diamonds, clarity is "Si", colour is "H".

Dimensions (average) = 2.00mm(L) x 2.00mm(W) x 1.42mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.20ct (estimated - see NOTE below)

Total Item Weight = 4.31 grams Total Gemstone Weight = 0.70ct Total Metal Weight = 4.17 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
