Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct white gold, diamond set, multistone, 'cluster' style ring, of cast construction.

Plain, narrow, low half round band of 1.92mm width (at base) x 1.20mm depth, with a hollow top and shoulders, open back settings and a curved underrail.

Feature square top plate housing nine round brilliant cut diamonds, claw set. Surrounding is two rows with a total of fifty round brilliant cut diamonds, claw set. The top plate is supported with a decorative gallery and in between the 'split' style shoulders, of the plain and polished band. Each of the shoulders houses twelve round brilliant cut diamonds, claw set.

Polished finish. Stamped '9K FJ' - acid tested as 9 carat gold. Ring size: N.

The ring contains:

- Four claw set round brilliant cut diamonds, clarity is "P2", colour is "I to J" (mixed).
Dimensions = 2.67mm(Dia) x 1.63mm(D-estimated) x 2%(Girdle Thickness) (smallest)
Dimensions = 2.98mm(Dia) x 1.82mm(D-estimated) x 2%(Girdle Thickness) (largest)
Total Weight = 0.35ct (estimated - see NOTE below)
- Seventy Nine claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "I to J" (mixed).
Dimensions = 1.07mm(Dia) x 0.65mm(D-estimated) x 2%(Girdle Thickness) (smallest)
Dimensions = 1.35mm(Dia) x 0.82mm(D-estimated) x 2%(Girdle Thickness) (largest)
Total Weight = 0.65ct (estimated - see NOTE below)

Total Item Weight = 4.21gm Total Gemstone Weight = 1.00ct Total Metal Weight = 4.01gm estimated

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
