Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct yellow gold and rhodium plated, cluster style, gem set, dress ring, of cast construction.

Plain, narrow, reverse tapered band of 2.20mm in width (at base) x 0.79mm depth, with curved and cut-out underrail, with open back settings.

Feature 'cluster' style ring design, consisting of one round brilliant cut diamond (largest), claw set to the centre, surrounded by eight round brilliant cut diamonds, also claw set. Secured between the extended shoulders of the plain and polished band.

Polished finish - stamped '14' - acid tested as 14 carat gold. Finger size is M.

The ring contains;

One claw set round brilliant cut diamond, clarity 'P2', colour 'G'.

Dimensions = 3.88mm(Dia) x 2.37mm(D-estimated) x 4%(Girdle Thickness)
Total Weight = 0.25ct (estimated - see NOTE below)

Eight claw set round brilliant cut diamonds, clarity 'Si & P1' (mixed), colour 'G'.

Dimensions (average) = 2.50mm(Dia) x 1.53mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 2.92 grams - Total Gemstone Weight = 0.75ct - Total Metal Weight = 2.77 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
