Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct white gold, diamond set, multistone ring, of cast construction.

Plain, narrow, low half round, tapered band of 1.98mm width (at base) x 1.04mm depth, with hollow top and shoulders, and a curved underrail.

Feature central railed four claw setting, housing one Princess cut diamond, claw set. The setting is secured to the underrail, and in between the extended and pointed shoulders of the plain and polished band. Each of the shoulders houses one row of six round brilliant cut diamonds, graduating in size, and channel set.

Polished finish.

Stamped '375 H' - acid tested as 9 carat gold.

Ring size: P.

The ring contains:

One claw set Princess cut diamond, clarity is "Si1", colour is "K".

Dimensions = 3.23mm(L) x 3.13mm(W) x 2.50mm(D-estimated) x 6%(Girdle Thickness)

Total Weight = 0.22ct (estimated - see NOTE below)

Twelve channel set round brilliant cut diamonds, clarity is "Si", colour is "H to I" (mixed).

Dimensions = 1.15mm(Dia) x 0.70mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.55mm(Dia) x 0.95mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.13ct (estimated - see NOTE below)

Total Item Weight = 2.34 grams Total Gemstone Weight = 0.35ct Total Metal Weight = 2.27 grams (estimated)



NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
