Valuation for Traditional Retail Insurance Replacement

Item 1

One, 10ct yellow gold and rhodium plated, diamond set, multistone, 'cluster' style ring, of cast construction.

Plain, narrow, low half round, tapered band of 1.94mm width (at base) x 0.90mm depth, with a hollow top and shoulders, open back settings, and a curved underrail.

Feature five rows of nine round brilliant cut diamonds, in shared claw settings, claw set. The settings form a 'pyramid' shape, and the diamonds graduate in size, largest to the centre. The settings are secured between the tapering shoulders of the plain and polished band. Rhodium plating to the setting areas.

Polished finish. Stamped '10K LJ' - acid tested as 9 carat gold. Ring size: L 1/2.

The ring contains:

Twenty Five claw set round brilliant cut diamonds, clarity is "P2 & P3" (mixed), colour is "light brown tint to brown tint" (mixed).

Dimensions = 2.40mm(Dia) x 1.46mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.67mm(Dia) x 1.63mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 1.50ct (estimated - see NOTE below)

Twenty claw set round brilliant cut diamonds, clarity is "P2 & P3" (mixed), colour is "light brown tint to brown tint" (mixed).

Dimensions = 2.03mm(Dia) x 1.24mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.30mm(Dia) x 1.40mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 4.89 grams Total Gemstone Weight = 2.00ct Total Metal Weight = 4.49 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
