## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 10ct white gold, diamond set, multistone, 'cluster' style ring, of cast construction.

Plain, narrow, low half round, tapered band of 1.53mm width (at base) x 1.04mm depth, with a hollow top and shoulders, open back settings, and a curved underrail.

Feature round top plate, within a four claw setting created from the upswept shoulders, of the plain and polished band. The top plate houses one round brilliant cut diamond, claw set, to the centre, and one row of nine round brilliant cut diamonds, surrounding the central setting, claw set. Each of the shoulders, houses one row of eight round brilliant cut diamonds, claw set.



Polished finish.

Stamped '10K FJ' - acid tested as 9 carat gold.

Ring Size: M.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Si", colour is "H".

Dimensions = 2.60mm(Dia) x 1.59mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.06ct (estimated - see NOTE below)

Twenty Five claw set round brilliant cut diamonds, clarity is "Si", colour is "H".

Dimensions = 1.27mm(Dia) x 0.77mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.15mm(Dia) x 0.70mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.19ct (estimated - see NOTE below)

Total Item Weight = 2.42 grams Total Gemstone Weight = 0.25ct Total Metal Weight = 2.37 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
