Valuation for Traditional Retail Insurance Replacement

One, 18ct white gold, multistone, gem set ring, of cast construction.

Plain, narrow, tapered band of 2.24mm in width (at base) x 1.42mm depth, with open back settings.

Feature shared claw and railed settings, housing a total of fourteen round brilliant cut diamonds, claw set. Secured between the shoulders of the plain and polished band.

Polished finish.

Stamped '750' - acid tested as 18 carat gold.

Finger size is O.

The ring contains:

Fourteen claw set round brilliant cut diamonds, clarity 'Si & P1' (mixed), colour 'G to H' (mixed). Dimensions (average) = 2.45mm(Dia) x 1.49mm(D-estimated) x 2%(Girdle Thickness) Total Weight = 0.75ct (estimated - see NOTE below)

Total Item Weight = 2.89 grams Total Gemstone Weight = 0.75ct Total Metal Weight = 2.74 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
