Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 14ct white gold, multistone, gem set ring.

Plain, narrow, tapered band of 1.57mm in width (at base) x 0.66mm depth.

Feature central four claw railed setting, housing one Princess cut diamond, claw set. Secured between the extended shoulders of the plain and polished band. Each shoulder having six round brilliant cut diamonds, tapering in size, channel set.

Polished finish - stamped '14K michael hill(partial)' - acid tested as 14 carat gold. Finger size is O.



The ring contains:

One claw set Princess cut diamond, clarity 'Si', colour 'H'.

Dimensions = 3.50mm(L) x 3.46mm(W) x 2.65mm(D-estimated) x 3%(Girdle Thickness)

Total Weight = 0.26ct (estimated - see NOTE below)

Twelve channel set round brilliant cut diamonds, clarity 'Si', colour 'H'.

Dimensions = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.80mm(Dia) x 1.10mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.18ct (estimated - see NOTE below)

Total Item Weight = 1.89 grams - Total Gemstone Weight = 0.44ct - Total Metal Weight = 1.80 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
