Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, diamond set, multistone, 'cluster' ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 1.46mm width (at base) x 0.70mm depth, with hollow top and shoulders, open back settings, and a curved underrail.

Feature central square top plate within a four claw setting, housing four Princess cut diamonds, invisibly set. The setting is secured to the underrail, and is framed with the extended and rounded shoulders, of the plain and polished band.

Polished finish.

Stamped '18CT' - acid tested as 18 carat gold.

Ring size: Q.

The ring contains:

Four invisibly set Princess cut diamonds, clarity is "Si & P1" (mixed), colour is "H".
Dimensions (average) = 2.85mm(L) x 2.85mm(W) x 2.02mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.54ct (estimated - see NOTE below)

Total Item Weight = 4.31 grams
Total Gemstone Weight = 0.54ct
Total Metal Weight = 4.20 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
