Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold and rhodium plated, diamond set, 'cluster' style ring, of cast construction.

Plain, narrow, low half round, tapered band of 2.36mm width (at base) x 1.11mm depth with a hollow top and shoulders, open back settings, and a curved underrail.

Feature round top plate with housing one round brilliant cut diamond, to the centre, claw set. Surrounding is one row of ten round brilliant cut diamonds, claw set. The top plate is supported with a decorative gallery, and in between the 'split' style extended and square shoulders, of the plain and polished band. Rhodium plating to the setting areas.



Polished finish.

Unstamped - acid tested as 9 carat gold.

Ring size: J 1/2 - K.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P2", colour is "H".

Dimensions = 4.65mm(L) x 4.63mm(W) x 2.82mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.43ct (estimated - see NOTE below)

Ten claw set round brilliant cut diamonds, clarity is "P2", colour is "H".

Dimensions (average) = 1.97mm(Dia) x 1.20mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.30ct (estimated - see NOTE below)

Total Item Weight = 2.96 grams Total Gemstone Weight = 0.73ct Total Metal Weight = 2.81 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
